In the years following the Civil War, the landmark Col. George Davenport home, oldest permanent residence in the Quad Cities, fell into decay. By the turn of the century, it was nearly lost. Then in 1906, his granddaughters and the "Pioneers and Old Settlers' Association of Rock Island County" acted to save it for future generations.

Now, a century later, your all-volunteer *Colonel Davenport Historical Foundation* plans to complete the task of restoring this magnificent landmark by rebuilding its original wings, providing space for interpretive exhibits, and, eventually, administrative offices. The central core of the home, and the new income-producing Sutlery are completed, but to realize our dreams will cost over \$750,000.

HISTORY MOMENT: DRED SCOTT CASE DECIDED 150 YEARS AGO

Do you remember the details of the case that factored in the beginning of the Civil War? In March 1857, the U.S. Supreme Court decided the case of *Dred Scott v. John F. A. Sanford* and it was quite possibly the most important case ever decided by our high court. To reverse its ruling, the nation fought the American Civil War.

In 1834, Dred Scott was a slave belonging to Dr. Emerson, who was a surgeon in the U.S. Army. He took Scott from Missouri to the military post at Rock Island, Illinois, and held him there as a slave until 1836. Dr. Emerson then took Scott from Rock Island to the military post at Fort Snelling in the Territory known as Upper Louisiana and held him there until 1838.

On November 2, 1853, Dred Scott filed his complaint in the Circuit Court of the United States, Missouri District. He sued for his freedom, alleging that he was a citizen of the State of Missouri, and that John F. A. Sanford, without law or right held him as a slave. Scott contended that Dr. Emerson caused Scott to become a free man when he took him to reside first at Rock Island, IL, and again when he took him to reside at Fort Snelling.

In reply, Sandford filed what would today be called a Motion to Dismiss the Plaintiff's case. The Judiciary Act of 1789 authorized the Federal Courts to hear suit between citizens of different states. Sanford's motion sought to overcome Scott's allegation that he was "a citizen of the State of Missouri" because Dred Scott "was not a citizen of Missouri … because he is a negro of African descent; his ancestors were of pure African blood and were brought into this country and sold as negro slaves."

The ruling was handed down from the Supreme Court on March 6, 1857. Despite the conclusion that the Court lacked jurisdiction, however, it went on to hold that Scott was not a free man. This was only the second time that the Supreme Court had found an act of Congress to be unconstitutional.

On September 12, 2007, at noon at the Arsenal Golf Club, the Colonel Davenport Historical Foundation will present an original "dialogue" discussing this case at its Lunch & Learn. That "dialogue," called "*A Shave and a Haircut - Two Bits*" is an original mini-play written by Judge John Donald O'Shea, a board member of the CDHF. The play is situated in a barbershop in March of 1857, with the dialogue derived from Cheif Justice Taney's majority opinion, the dissenting opinions of Justices McLean and Curtis, and the editorials of three local newspapers.
